

SECTION A: PERMIT TO REMOVE TREES FROM PRIVATE PROPERTY

A permit to remove trees on private property is only required as part of an application presented to the Building Department or Land Use Boards for development. If the property owner wishes to remove and/or destroy any tree on their property prior to the submission of an application to the Building Department or Land Use Boards (i.e., as a step to prepare the property for an anticipated future development project), then the property owner is required to apply for a permit and receive approval before such tree removal work can begin. This requirement remains applicable for up to two years prior to an application being submitted to the Building Department or Land Use Boards and applies to development projects involving the complete "above foundation" demolition of the current structure(s) on the property (i.e., does not apply to renovation and/or alterations).
