THE REORGANIZATION MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF ORADELL WAS HELD IN THE AUDITORIUM OF ORADELL PUBLIC SCHOOL 350 PROSPECT STREET ON JANUARY 7, 2024 AT 12:15 PM.

1. CALL TO ORDER- OPEN PUBLIC MEETINGS ACT – ROLL CALL

Laura Lyons, Municipal Clerk called the meeting to order and the Statement of Compliance with the Open Public Meeting Act was read. She welcomed Pat Schuber, Borough Historian who served as Master of Ceremonies.

Mr. Schuber provided opening remarks, announced the dignitaries in attendance and welcomed the governing body-elect members and their families.

<u>PRESENTATION OF COLORS</u> – led by Police Officer Dan O'Leary playing bag pipes, Oradell Volunteer Fire Dept as well as members of the Oradell Police Dept.

<u>INVOCATION</u> – The invocation was provided by Father Christian Scalo, Administrator, of St. Joseph RC Church.

<u>PRESENTATION OF CERTIFICATES OF ELECTION</u> – Bergen County Clerk, John Hogan provided a summary of results from the November 7, 2023 General Election. He stated that overall Bergen County had a 31% turnout of registered votes. He highlighted the remarkable turnout from Oradell at 46.13% and stated it was the highest municipal turnout of all Bergen County towns. The County Clerk presented the Certification of Election, and announced that with a total of 1,614 votes James G Koth III was duly elected to serve a Mayor of Oradell for a full 4-year term.

The County Clerk presented the Certificate of Election, and announced that with a total of 1,484 votes Jonathan Kern was duly re-elected as Councilman for a full 3-year term.

The County Clerk presented the Certificate of Election, and announced that with a total of 1,612 votes, James "Ted" Gullo was duly elected to serve as Councilman for a full term.

OATH OF OFFICE-

Avram Soloman Turkel, Esq administered the oath of office to Councilman Jonathan Kern for a three-year term expiring on 12/31/26 (Councilman Kern was accompanied by his family, with his wife Sonia holding the bible)

Honorable Erik Acosta administered the oath of office to Councilman James "Ted" Gullo for a three-year term expiring on 12/31/26 (Councilman James "Ted" Gullo was accompanied by his family, with his daughter Claire holding the bible)

<u>INTRODUCTION OF BERGEN COUNTY EXECUTIVE-</u> Steven A. Tanelli, Bergen County Commissioner introduced Mayor -Elect James G. Koth III and Bergen County Executive James J. Tedesco III and provided comments.

Mr. Tedesco provided commentary regarding serving Bergen County with Mayor-Elect Koth.

Mr. Tedesco administered the oath of office to Mayor James G. Koth III (Mayor Koth was accompanied by his family with his son James holding the bible)

MAYORS WELCOME AND OPENING ADDRESS – Mayor Koth thanked the County Executive and Commissioner Tanelli for their comments and participation. He acknowledged Councilwoman Tracy Schoenberg and her running mates for their efforts in the election process. He requested a round of applause for them. He congratulated Councilman Kern and Councilman Gullo on their election and stated he is looking forward to working together along with the other members of the governing body throughout the year. He thanked all those in attendance despite the unfavorable weather conditions. He thanked the DPW and OPS ground crew for storm cleanup as well as the continuous work each day for the community. He remarked on the significance of the inclement weather as symbol of his father's presence on the day. He recognized and thanked his wife Sam and children Maddie and James IV for their support in his entry to the election process. He acknowledged the support of his mother and family members. He thanked the Municipal and Deputy Municipal Clerk for their efforts in preparing for the Reorganization Meeting. He emphasized the decision to move the location of the meeting from Borough Hall to the Oradell Public School Auditorium. He stated it served as an example that the current Mayor and Council will not rest on past practice operations as a means of governing moving forward. He stated he is confident that the future of the community is bright. He thanked the members of the Council for their passion and efforts in their service to the community. He acknowledged former Mayor Didio for her fourteen years of service to Oradell as well as Councilman Robert Jannicelli for his six years of service.

He stated that service to the community requires commitment to twenty-four hours a day, three-hundred sixty-five days a year operation. He stated that challenges arise when not expected as in the need to create an Oradell You Tube channel late in the evening yesterday in order to ensure the broadcasting of today's event. He thanked his wife Sam, Laura Lyons, Municipal Clerk, Megan Bozios, Superintendent of OPS and her staff in the successful establishment of the You Tube Channel. He outlined the commitment of the governing body to maintain ethical standards of transparency of government. He stated that enhancement of communication to the public will be addressed as well as improving operations in the building department and land use boards. He stated the Governing Body will work with Borough staff to increase morale and ensure professional development opportunities. He stated the Council will be focused on financial responsibility to safeguard the public's trust and preserve the sense of community unique to the Borough.

He provided a sincere appreciation to all the volunteers for their exemplary civic dedication by serving in different roles that collectively make Oradell a superlative community.

Pat Schuber gave closing remarks and introduced Reverand Dr. Hansel Asmar, Sr who provided the Benediction.

A brief recess was held to transition to the business portion of the Reorganization meeting.
