## **ALARM SYSTEM REGISTRATION**

All alarms must be registered with the Oradell Police Department.

All such registrations shall be valid for the calendar year in which they are issued and shall be renewed annually on a calendar year basis, before February 1<sup>st</sup> of such year.

Fees payable to the Police Department, upon registration and/or renewal thereof, shall be in accordance with Chapter 115 of the Code of the Borough of Oradell entitled "Fees."

### ORADELL POLICE DEPARTMENT - APPLICATION FOR REGISTRATION OF SECURITY ALARM SYSTEM

The Owner of the Security Alarm System described on the reverse hereof (the "Owner") hereby makes application to the Police Department of the Borough of Oradell for the registration of said Alarm system pursuant to Chapter 210 of the Code of the Borough of Oradell. The Owner hereby agrees to abide by the provisions of said Chapter. Without limiting the generality of the foregoing, the Owner acknowledges the provisions of the following sections:

"210-13. **Disclaimer of Liability.** The Borough of Oradell, its various departments, agencies, employees and officials, shall be under no duty or obligation hereunder to any Alarm System owner or to any other person or persons, with respect to the adequacy, operation, installation, repair or maintenance of the Alarm Console and any allied equipment or services and assumes no liability in connection therewith, the Alarm Console and equipment being maintained at will and subject to termination at any time by cancellation by resolution duly adopted by the Mayor and Council of the Borough of Oradell, and any individual registration hereunder may be revoked any time by the Mayor and Council upon recommendation of the Chief of Police provided thirty (30) days notice is given in the writing to the Alarm System owner. Registration of any Alarm System pursuant to this Chapter shall be subject to the express condition that the Alarm System owner, by registering such Alarm System, does thereby waive any claim against the Borough of Oradell, its various departments, agencies, employees and officials from and on account of any and all damages arising out of the Borough's installation, operation or maintenance of the Alarm Console or any such Alarm System."

"210-5. **Access to Premises.** The owner of any Alarm System registered pursuant to this Chapter may leave with the Police Department the names of residents of the Borough of Oradell who have keys to the premises or, in lieu thereof, a sealed key to provide entry to the premises may be left with the Chief of Police, providing that in so doing the owner does thereby release the Borough of Oradell, its various departments, agencies, employees and officials from any claims for damages or loss in connection with such entry."

"210-10. **Response to Alarms.** In responding to any alarm signal indicating a panic alarm or medical emergency, if so authorized by the Alarm System owner in the application for registration, the Police Department may enter the premises, by force in necessary, to respond to such signal, and the Alarm System owner in granting such authorization shall do so on the express condition that by registering said Alarm System and authorizing such entry, said owner does thereby waive any claim against the Borough of Oradell, its various departments, agencies, employees and officials, from and on account of any and all damages as a result of such entry. In the event the Alarm System owner, in the application for registration, withholds permission for such entry, the Borough and its various departments, agencies, employees and officials, assumes no duty or obligation to attempt to gain entry to the premises, and shall have no liability for its failure or inability to respond to such panic alarm or medical emergency.
