## **Old Business**

## Programming and Certificate of Insurance

- Certificate of Insurance (COI): Lot of push back from the borough. Hold Harmless
  for residents to give speeches and presentations might be but the borough is
  scared to take risk. Triggered audit to make sure it is fair across the board (ie:
  Farmer's Market, guitarist, etc.). Of more concern for safety are the several
  bricks in front of the library building that are loose and need to be addressed.
  This is riskier than not having an insurance certificate for performers.
- Is there a rider that can be added to the borough policy to cover library? Providing services is what the library does cost of doing business. Less risky than the borough's Independence Day beer gardens, etc. Burden to the library, loss to the community. Has never been any lawsuits against the library in at least the past 11 years (since John's been here). Borough insurance agent Gerard Quinn's solution to this?
- Oradell is one of the only libraries that requires any kind of insurance. Others
  require hold harmless agreements, but not certificates of insurance. They are
  surprised when they hear we do. (e.g. River Edge Public Library).
- New Jersey Maker Day: Lin Loh wanted to start lining up vendors, teachers, and volunteers. Wanted to know who needed to be covered with a COI.
- Monroe Quinn, music director at \$t Joe's, to come in and perform Dec 29th. The library would have to guarantee insurance for him. Can we extend our insurance to cover him?

#### Strategic Plan and Return of Funds

- Strategic Plan is one part of the Transfer of Funds application and it is done.
- Respondents rated the kinds of programs they would like to see at the Library:
  - Music, concerts: 38.89%
  - Performing arts, theater: 34.03%
  - Computers and technology: 31.94%
  - Cooking: 28.4%
  - Foreign language: 28.47%
  - Health and fitness: 28.47%
  - Social events (beer or wine tasting): 28.47%
  - Travel: 26.39%History: 25.69%
  - Home and garden: 22.22%
  - Personal finance: 19.44%
  - Creative/design (Makerspace): 18.75%
  - Job search and careers: 16.67%

• Residents already feel services are being cut, if we did away with these, residents would be angry.
