COMMITTEE REPORTS

Administration

Council President Tracy Schoenberg stated she will be meeting the Borough Administrator next week to finalize changes to the Admin Code ordinance in anticipation of Introduction at the April Public Meeting. She stated the Borough had the initial negotiations with the UPSEU and after a response from Labor Counsel another meeting will be scheduled. She reported the Fire Department responded to 11 calls during the month of March. She stated the Senior Citizen Advisory Committee met on February 2nd and various topics were discussed. New programming

will be added during the year and she summarized upcoming events including the Senior Prom sponsored by The River Dell Interact Club to be held tomorrow March 29th. She reported that 70 seniors attended the St. Patrick's Day luncheon and she thanked the Bergen County Players for inviting the Seniors to attend dress rehearsals.

DPW

Councilman Roger Tashjian

The Borough Engineer reported that each municipality will be required to update their storm water mapping January of 2024. The state is providing a \$25,000 grant to help municipalities offset the cost. The Engineer reported that the borough is in a good position with the status of mapping. He gave a brief description of the process and summarized the DEP's objectives the next round.

The Borough Engineer provided an update on the Memorial monument project. He stated permits should be submitted to the Building Dept to ensure the flag poles can be installed in the next 2-3 weeks.

Councilman Tashjian summarized the upcoming paving projects. Iroquois Street and Schirra Drive have been identified to be repaved. He stated the new sign board was installed and the electric service needs to be finished in order to go live. He reported since there was very little snow this winter the overtime line item budget is in good shape.

Councilman Carnevale requested that Poplar Road be inspected to ascertain when it can be paved.

Public Safety & Emergency Management

Councilman Stephen Carnevale reported the Police Department will be conducting a pedestrian safety initiative on Kinderkamack Rd in the downtown district mid-April. Two new push button pedestrian crossing signs on Kinderkamack Rd will be installed at Meyerhoff and Park Ave. He reminded residents to sign up for OradellAlert to get the most up to date information. He

provided an update on recent Planning Board actions and stated the Historical Committee will be discussing creating a mission statement.
