Councilman Tashjian questioned the need to appoint official newspapers in resolution 22-34. The Borough Administrator/Municipal stated that this is still a statutory requirement. It was agreed that in addition to the newspaper various public notices would be placed on the Bor He asked about having one of our designated "newspapers" or designated forms of communication be an online outlet. Borough Administrator explained how the NJ Municipal Clerks Association has actively lobbied for this for almost a decade & unfortunately no statues have changed. She mentioned how she can add that in but we are not able to use it solely as our medium until those statutes are changed. Councilman Tashjian said Yes, he would like to see the Borough Website added to the list of media outlets. Laura agreed with Roger but referred to the Borough Attorney because there are certain statutes that need to be adhered to. Andrew Oddo, Borough Attorney agreed with everything Laura said that we need to use the newspapers that we use but there may be some alternative newspapers. But there is nothing that prevents us from adding something beyond the statutory requirements such as our website or any other website. So inconclusion, Councilman Tashjian made a motion to amend Resolution 22-34 to add the Borough website. Councilman Carnevale asked the Borough Attorney if we add the Borough website & for some reason the website goes down, have we still fulfilled our statutory requirements by having it in the newspaper as well? Borough Attorney confirmed that Councilman Carnevale was correct. As long as we comply with the statute, anything we do or don't do beyond that isn't a problem.
