TRUST FUND APPLICATION MUNICIPAL ENDORSING RESOLUTION

WHEREAS, the Bergen County Open Space, Recreation, Floodplain Protection, Farmland & Historic Preservation Trust Fund (the "County Trust Fund"), provides matching grants to municipal governments for assistance in the development or redevelopment of municipal recreation facilities; and,

WHEREAS, the Borough of Oradell (the "Borough") had received a 2017 Trust Fund matching grant award of \$15,000, which was approved via County of Bergen Board of Chosen Freeholders Resolution No. 729-18, dated 8/1/18, for its "Municipal Dog Park- Oradell" project (Project Contract No. 1800246); and,

WHEREAS, the Borough Council decided due to surrounding dog park amenities the project funding would be better suited at the inclusive playground at Hagler Park; and

WHEREAS, the Borough of Oradell desires to transfer its 2017 Trust Fund Municipal Program grant award to the (*Inclusive Playground at Hagler Park*) project; and,

WHEREAS, the governing body has reviewed the County Trust Fund Program Statement, and the Trust Fund Municipal Program Park Improvement application and instructions and desires to make such a request for use of its grant and provide application information and furnish such documents as may be required; and,

WHEREAS, as part of such request, the governing body received public comments on the proposed transfer and use of its 2017 Trust Fund Municipal program grant award on January 4, 2022; and,

WHEREAS, the County of Bergen shall determine whether the proposed request and use of the 2017 Trust Fund grant award are complete and in conformance with the scope and intent of the County Trust Fund; and,



WHEREAS, the Borough is willing to use the County Trust Fund grant in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the County of Bergen for the approved project.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council:

- 1. That it is hereby authorized to withdraw its 2017 Municipal Dog Park project application to the County; and,
- 2. That is will submit a certified copy of this resolution along with its written request to the County Trust Fund to withdraw its 2017 Municipal Dog Park project and to apply its 2017 Trust Fund grant award towards the *Inclusive Playground at Hagler Park*); and
- 3. That it has, or will secure, the balance of funding necessary to complete the Inclusive Playground at Hagler Park project, or modify the project as necessary; and,
- 4. That it is committed to providing a dollar-for-dollar cash match for the Inclusive Playground at Hagler Park; and,
- 5. That only those park improvements identified and approved in its Inclusive Playground at Hagler Park project application, its Trust Fund contract, or other documentation will be considered eligible for reimbursement.
- 6. That it agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project; and,
- 7. That this resolution shall take effect immediately.
