WHEREAS, Public Comment protocols shall be: In advance of the remote public meeting, members of the public shall be permitted to submit public comments by electronic mail and in written letter form to the Borough Clerk at llyons@oradell.org and Laura Lyons 355 Kinderkamack Road Oradell NJ 07649 by 3:00 PM on meeting day. Public comments submitted through electronic mail or written letter shall be read aloud from the beginning and addressed during the remote public meeting in a manner audible to all meeting participants and the public listening; and

WHEREAS, Standard of conduct to be followed by members of the public when making comment are as follows: If a member of the public becomes disruptive during a remote public meeting including during any period for public comment the Borough Clerk (member charged with administering the remote meeting) shall mute or keep on mute the disruptive member of the public and warn that continued disruption may result in their being prevented from speaking or removed from the remote public meeting. Disruptive conduct includes sustained inappropriate behaviors such as, but not necessarily limited to, shouting, interruption and use of profanity; and

WHEREAS, a member of the public continuing to act in a disruptive manner after receiving an initial warning may be muted or kept on mute with other members of the public allowed to proceed with their questions or comments. If time permits the disruptive individual shall be allowed to speak after all other members of the public have been given the opportunity to make comment. In the event the individual remains disruptive, the individual may be muted or kept of mute for the remainder of the remote public meeting, or removed altogether from the remote public meeting; and

WHEREAS, worldwide pandemic has occurred involving a novel Coronavirus more commonly known as COVID-19; and

WHEREAS, on March 9, 2020 Governor Murphy issued Executive Order 103 declaring a State of Emergency and a Public Health Emergency in response to the outbreak of the novel Coronavirus within the State of New Jersey; and

WHEREAS, on March 16, 2020 Governor Murphy issued Executive Order 104 enacting several "social distancing" regulations including but not limited to public gatherings to no more than 50 people, closing educational facilities, closing various recreation and entertainment-based business, imposed restrictions on scope of service and hours of operation for other non-essential retail, recreational, restaurants/bars and entertainment business; and

WHEREAS, on March 21, 2020 Governor Murphy issued Executive Order 107 which expanded the social distancing regulations set forth within Executive Order 104m, including but not limited to directing all New Jersey remain in their home or place of residence with specific limited exceptions, prohibited gatherings of any size, closed all non-essential retail businesses and identified essential businesses permitted to continue to operate subject to specific limitations, and reiterated and strengthened social distancing requirements when in public; and

WHEREAS, on March 21, 2020 Governor Murphy issued Executive Order 108 which specifically voided and precluded County and Municipal Governments from imposing or enforcing any restrictions/regulations that in any way would or might conflict with any of the provisions of Executive Order 107 with the exception of regulating online marketplaces for arranging or offering lodging, municipal or county parks and beaches and boardwalks; and

WHEREAS, Executive Order 107 specifically regulations the continued operation of Bars/restaurants and provides, in part, that "All restaurants, cafeterias, dining establishments and food courts, with or without a liquor license, all bars and all other holders of a liquor license with

retail consumption privileges are permitted to operate their normal business hours, but are limited to offering only food delivery and/or take out services in accordance with their existing liquor licenses" and

WHEREAS, on June 3, 2020 Governor Murphy issued Executive Order 150 which allows outdoor dining at food or beverage establishments in New Jersey starting on Monday June 15, 2020 provided that establishments follow a number of COVID-19 health and safety protocols issued by the New Jersey Department of Health including of eight customers per table, requirements of at least 6 feet of distance between parties and a prohibition on smoking in any outdoor areas designated for the consumption of food and/or beverages; and

WHEREAS, Executive Order 150 further notes that Municipal Governments are permitted to use their existing authority to allow food or beverage establishments to expand their footprint to outdoor areas, both within their property and among municipally-governed areas, including but not limited to sidewalks, streets, or parks; and

WHEREAS, in consideration of the above and the great hardship and uncertainty the COVID-19 public health emergency has caused to the business of Oradell, the Governing Body desires to support the economic recovery of local restaurants and business by temporarily modifying certain outdoor dining restrictions so that the restaurants are able to serve customers while satisfying social distancing requirements; and

WHEREAS, the Borough COVID-19 task force have reviewed this topic and sample handouts and found the temporary medication satisfactory; and

WHEREAS, the Governing Body finds it in the best interest of the Borough to temporarily modify certain restrictions.

NOW THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Oradell in the County of Bergen and State of New Jersey as follows:

- Outdoor dining shall be temporarily permitted as an accessory use to all restaurant uses, including food service establishments.
- 2. Temporary outdoor dining as permitted by this resolution shall not require the filing of a site plan application with the Borough Land Use Boards.
- 3. A temporary outdoor dining application (applicants can use the existing "outdoor café application) prior to the creation or expansion of any outdoor dining area. A drawing of the proposed outdoor dining area must accompany the application. The drawing shall show the location, size and quantities of all proposed tables and chairs and distances to other table and chairs and distances to other structures. All distance separations shall comply with all Executive Orders issued by the Governor of the State of New Jersey, as well as any other requirement, conditions, and/or limitations in any applicable Executive Directives on Outdoor Dining and those established by the State Division of Alcohol Beverage Control
- 4. The Borough shall waive the filing fee for a Temporary Outdoor Dining Application and all 2021 fees paid for established outdoor cafes should be reimbursed.
- 5. The regulations pertaining to outdoor cages shall be temporarily suspended and replaced with the following standards which shall be applicable to temporary outdoor dining:
 - a. The number of seats permitted in the outdoor dining area may not exceed 50% of the total seating capacity previously approved for the eating and/or

drinking establishment.

- b. Outdoor dining areas may be located on patios, walkways, plaza and courtyards in a manner that does not impair pedestrian circulation. Outdoor dining areas may also be located at the discretion of the Zoning Officer on public sidewalks and private lawn and parking lots provided pedestrian and vehicular circulation is not impaired and further provided in the case of parking lots that outdoor dining shall not occupy more that 35% of the minimum number of required spaces for the totality of the site's uses.
- c. Where outdoor dining is proposed within a parking lot, driveway or roadways, bollards or other protective structures approved shall be erected along the perimeter of the outdoor dining area in order to ensure public safety at the discretion of the Borough Engineer.
- d. All temporary outdoor dining areas must be closed by 9:00 PM and all eating furniture, tables, chairs, umbrellas should be taken in or secured.
- e. If outdoor dining area is proposed to be utilized after dark, temporary lighting shall be required. However, such lighting shall require an electrical permit unless an adequate existing outlet is to be used.
- f. Landscaping and landscape planters around and/or within the outdoor dining area shall be permitted and are encouraged but are not required.
- g. Awnings, umbrellas, canopies are not permitted to be attached to a building. Tents and umbrellas need to be secured to the ground to prevent blowing over and no advertisement can be placed on umbrellas and/or tents.
- h. Eating and drinking establishments may display one temporary sign per street frontage, each not to exceed to notify the public of an in-house take-out and/or outdoor dining options and any restrictions in place dur to the COVID-19 public health emergency. Such temporary signs shall be non-illuminated.
- i. Establishments are permitted sandwich signs sized 2 x 3 to be approved by the Zoning officer to be displayed in front of their property.
 - All outdoor dining areas must adhere to open/close regulations as stated in the Borough Code. The Borough shall have the discretion to enforce measures to mitigate or eliminate nuisances including the revocation of a temporary outdoor dining permit.
- k. Temporary outdoor dining facilities shall provide access to restrooms for patrons as may be required by the State and Borough Health Department. If a participating establishment does not have public bathrooms, they must have the written consent attached to their application from an establishment within their building for patron.
- I. The Borough Zoning Officer shall have the discretion to may additional standards for a particular property for Borough Council review and approval to ensure the public health, safety and welfare.
- 6. In addition to the above, the outdoor dining areas must comply with applicable Executive Orders issued by the Governor of the State of New Jersey as well as any other requirements, conditions, and/or limitations in any applicable Executive Orders, including but not limited to the New Jersey Department of Health Executive Directive on Outdoor Dining. Eating and Drinking establishments shall also continue to follow all rules and regulations of the Health Department and Division of Alcoholic Beverage Control as well as applicable local, state and federal laws.
- 7. This resolution shall be effective March 23 2021 and remain in effect until the end of

- outdoor Café season, unless this resolution is otherwise amended or vacated by the Borough Council.
- 8. This resolution does not permit the construction of or alternation to any building or structure. No changes may be made that alter the existing character of any building or structure.
- 9. Smoking shall be prohibited within 50 feet of all outdoor dining areas.

Resolution 21-84 Borough of Oradell Bergen County

RESOLUTION DECLARING SOLIDARITY WITH THE ASIAN AND ASIAN-AMERICAN COMMUNITY

WHEREAS, hate crimes motivated by anti-Asian sentiment have jumped 1,900% in New York City in 2020 and almost 3,000 reports of anti-Asian discrimination between March 19 and December 31, 2020 have been recorded by the Stop AAPI Hate;

WHEREAS, racially-motivated assaults and harassment targeting of Asian and Asian-American seniors have dramatically increased, including the recent attack and subsequent tragic death of 84-year-old Vicha Ratanapakdee in San Francisco on January 28, 2021;

WHEREAS, in response to the xenophobic and inflammatory rhetoric about COVID-19, President Joseph Biden issued an Executive Memorandum on January 26, 2021, during the first week of his administration;

NOW THEREFORE BE IT RESOLVED by the Mayor and Council to:

- 1. Condemn and denounce racism, xenophobia and intolerance in all forms.
- 2. Call on public officials in other municipalities and at the state level to condemn and denounce racism, xenophobia and intolerance in all forms and stand with us in solidarity with the Asian and Asian Americans and Pacific Islanders communities.
- 3. Continues to promote and advocate for equality and equity through all policies approved by the Mayor and Council.
- 4. Recognize the dedication of Asian and Asian-American frontline medical workers, teachers, police and fire officers and essential workers. They along with their colleagues show up to work every day so that our society can still function. The strain of COVID is particularly heavy for Asian and Asian-American frontline and essential workers because they have been personally attacked for their ethnicity in the midst of providing their essential services to us.
- Continue to advocate locally and through the New Jersey State League of Municipalities, New Jersey Conference of Mayors and all other appropriate associations for relevant policies that improve health in communities of color.
- 6. Support local, state, regional, and federal initiatives that advance efforts to dismantle systemic racism.
- 7. Further work to solidify alliances and partnerships with other organizations that are confronting racism and encourage other local, state, regional and national entities to recognize racism as a public health crisis.
- 8. Promote and support policies and resources that prioritize the health of all people, such as bystander intervention programs like https://www.ihollaback.org/bystanderintervention/.
- 10. Encourage racial equity training among all community partners, vendors and contractors.

- 11. Call upon Bergen County Executive Tedesco and the Bergen County Board of Commissioners to declare racism as a public health crisis and to enact equity in all policies in the County of Bergen.
- 12. Call upon Governor Murphy, State Senate President Sweeney, and State Assembly Speaker Coughlin to also declare racism as a public health crisis and to enact equity in all policies of the state of New Jersey.

Resolution 21-85

Resolution Urging The Legislature To Amend Senate Bill 3454 (Also Known As Assembly Bill 5342) To Permit Law Enforcement Officers To Perform Their Duties Without Substantial Risk of Civil and Criminal Liability

WHEREAS, Senate Bill 3454 (also known as Assembly Bill 5342) (collectively "the Legislation"); and

WHEREAS, the Legislation prohibits law enforcement officers from engaging in certain actions when investigating an individual under the age of 21 for possession of marijuana, hashish, cannabis, or alcohol. The legislation criminalizes the conduct of officers who respond to a call for service or are investigating the underage use of marijuana, hashish, cannabis, or alcohol by:

- no longer allowing the odor, possession or consumption of marijuana, hashish, cannabis or alcohol to be used as reasonable articulable suspicion to initiate a stop of an individual under the age of 21, nor does it provide probable cause to search the person's personal property or vehicle,
- no longer allowing for marijuana, hashish, cannabis or alcoholic beverages, observed in plain sight to constitute probable cause to initiate a search of an individual under the age of 21 or that individual's personal property or vehicle,
- an individual under the age of 21 shall not be arrested, detained, or otherwise taken into custody except to the extent required to issue a written warning.
- Officers are further prohibited from contacting the minor's parent or guardian to advise them of the minor's possession or consumption of marijuana, hashish, cannabis or alcoholic beverages for the minor's first offense.

WHEREAS, the Legislation will discourage officers from enforcing underage use and possession of marijuana, hashish, cannabis, or alcohol and will specifically expose officers to civil and criminal liability for the deprivation of civil rights, even if the officer did not act with specific intent to deprive a person of his or her civil rights; and

WHEREAS, the Governing Body believes that the Legislation will result in officers avoiding situations where criminal conduct has occurred to limit exposure to civil and criminal liability; and

WHEREAS, the Governing Body is of the opinion that the Legislation creates significant burdens on law enforcement and will obstruct police officers from performing their duties and conducting lawful investigations of individuals under the age of 21, who possess or consume any amount of marijuana, hashish, cannabis, or alcohol in any

public place, including a school, criminalizing law enforcement actions; and

WHEREAS, the Legislation will severely limit the ability of law enforcement agencies to police our community effectively, increase risks to children from illicit drugs and alcohol, and fail to protect society from criminal drug activity and impaired drivers to the detriment of public safety.

NOW THERFORE BE IT RESOLVED by the Mayor and Council that it does hereby indicate its strenuous apposition to the Legislation and urge members of the State Senate and General Assembly to immediately enact amendatory Legislation so as to permit law enforcement personnel to perform their duties in the interest of safety and general welfare without substantial risk of civil and criminal liability.
