

**BOROUGH OF ORADELL
ORDINANCE # 24-5**

**AN ORDINANCE AMENDING CHAPTER 235-11 ENTITLED
PERMIT; RESTRICTIONS ON EXCAVATING RECENTLY SEALED ROADS
OF THE CODE OF THE BOROUGH OF ORADELL**

WHEREAS, the Governing Body of the Borough of Oradell wishes to amend Chapter 235-11(D) which pertains to non-opening of roads for a period within seven years of the time that a road is sealed; and

WHEREAS, the Governing Body of the Borough of Oradell wishes to increase the non-opening of such roads from within five years to seven years of the time that the road is sealed.

NOW THEREFORE BE IT ORDAINED, that Chapter 235-11(D) is hereby amended as follows:

Non-opening of road. No street, road, or paved area constructed, reconstructed or repaved within seven years of the time that the road is sealed can be excavated, built or patched except in the case of emergency, which includes but is not limited to gas leaks, without prior approval of the Mayor and Council.

AND BE IT FURTHER ORDAINED, that all other provisions and requirements of this Chapter shall remain in full force and affect.

**CALENDAR YEAR 2024
ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS
AND TO ESTABLISH A CAP BANK
(N.J.S.A. 40A: 4-45.14)**

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Governing Body of the Borough of Oradell in the County of Bergen finds it advisable and necessary to increase its CY 2024 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Governing Body hereby determines that a 1.0 % increase in the budget for said year, amounting to \$139,668 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Governing Body hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Governing Body of the Borough of Oradell, in the County of Bergen, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2024 budget year, the final appropriations of the Borough of Oradell shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$488,839, and that the CY 2024 municipal budget for the Borough of Oradell be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
