# **FINANCE REPORT:**

Mrs. Schmidt reported on revenue and expenses as of January 31, 2019:

- Expenses (NJ State Dog Licensing Report) totaled \$266.40.
- Revenue totaled \$5,093.00, provided by Transcripts (\$100.00), Business Licenses (\$2,725.00), Dog/Cat Licenses (\$2,265.00) and Marriage licenses (\$3.00).

The balance in the Animal Control Trust was \$11,862 as of January 31, 2019.

#### **OLD BUSINESS:**

The OBOH has not yet received the data requested from the Oradell Outreach Committee in support of the proposed Community Nurse program.

#### **NEW BUSINESS:**

Members briefly discussed Paramus' new regulation disallowing single-use plastic bags. Concern was raised regarding reuse of "permanent shopping bags" that have carried raw meats and the leak of fluid/blood, which can contaminate other items if the bags are not properly washed between uses. Mrs. Schneider, who is a Registered Dietician, will search for an article on proper washing for inclusion in the Town News.

#### ADJOURNMENT:

Since there was no further business to be discussed, Ms. Battaglia moved that the February 10, 2020 meeting of the Oradell Board of Health be adjourned at 8:31 pm; Dr. Diciedue seconded the motion. Voting: all in favor, none opposed. The next meeting will be on March 9, 2020, at 8:00 pm. Mrs. Schmidt noted that she will be out of state for work and will not attend the meeting.
