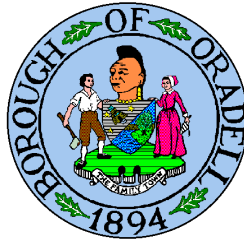

Minutes of the Meeting of the Oradell Board of Health May 21, 2018

The May 21, 2018 meeting of the Oradell Board of Health (“OBOH”) was called to order by Mrs. Catherine Yaxley-Schmidt, Chairperson, at 8:03 pm.

PRESENT: Ms. Mary Battaglia, Mrs. Anna Djurdjinovic, Mrs. Janet Schneider, Mrs. Catherine Yaxley-Schmidt, Ms. Karen DePol (2nd Alternate) and Ms. Lisa Nassor, County Sanitarian.

EXCUSED: Mrs. Nicole Chiarello-Alvarez, Dr. Kathleen Dicedue, Dr. Armando Fernandez, Ms. Donna Viscardi (1st Alternate), and Mr. Andrew Rudman, (Council Liaison).

APPROVAL OF MINUTES:

A motion to approve the minutes of the regular meeting of the Oradell Board of Health held on April 9, 2018 was made by Ms. Battaglia, and seconded by Mrs. Djurdjinovic. Vote: all in favor; none opposed.

Mrs. Schmidt reported that members received the following written communications:

Mrs. Schmidt noted that she had email correspondence with Mr. Andrew Oddo, Borough Attorney, updating him re the April 9, 2018 meeting of the OBOH; and, Mayor Dianne Didio and Melissa Presta re an Eagle Scout project.

Mrs. Schneider reported that she had received notice of a proposed urgent care center to be located at the corner of Kinderkamack and Ridgewood, at the former Liberty Subaru “quick lube” station. The proposal will be discussed during the June 4 Planning Board meeting.

COUNCIL LIAISON REPORT:

Members expressed their interest in Mr. Rudman following up on scholarships using Trust Fund monies that have been transferred to the general municipal funds; the proposed amendment to Chapter 240 "Land Use" banning sales of recreational marijuana within the Borough; any updates on the EPA monitoring of seepage near the former gas station at the corner of Kinderkamack and Cooper; and whether the Borough requires licensing of vendors selling e-cigarettes, vapes and related. Mrs. Schmidt will contact Mr. Rudman.

HEALTH REPORT:

Ms. Nassor noted that she would be serving as the regular inspector for Oradell, and discussed the month's inspections. There were no critical issues.
