Public Comment

Mayor Didio opened the meeting to the public.

Paul Latsounas, 50 Beverly Rd., inquired as to whether the minutes and/or documentation have been found with respect to the adoption of an historical element. Mrs. Lyons responded that she has searched, and will continue to search, to determine if the historical element was previously adopted.

Mr. Latsounas found seven cars that were parked in the lot behind the Oradell Post Office that did not have a resident sticker. Councilman Carnevale said that the matter was discussed in a public safety committee and will be further discussed. He said that technically, a sticker is required in order to park in the lot.

Mr. Latsounas said that the NJDEP has received \$14,000,000 in funding for towns to enhance their recycling efforts. The resident would like to see the borough receive some of this money and used toward upgrading the paving at the recycling lot to eliminate the potholes and puddles. He suggested that the grant writer apply for funding.
