Mrs. Lyons reported that Family Day is scheduled for September 30th with rain date of October 7th. She stated that she is working on a "Date Night" movie night and "Teen Night" event with more details to be announced as plans are finalized.

She also echoed the statements made by Councilman Jannicelli and thanked Melissa Presta from her office in organizing the 4th of July festivities. She added that Ms. Presta begins the process

for these events very early in the year, it is a lot of hard work to carry out.

Councilman Tashjian inquired as to offering a food truck dinner event weekly. Mrs. Lyons stated that Ms. Presta is looking into the details.

Borough Attorney's Report:

On Thursday, Mr. Oddo will be attending a Fairness Hearing before Judge Toskos to memorialize the agreement as between the Borough and Fair Share Housing Council.

Old Business:

Council President Schoenberg thanked Little League for hosting the beer garden at the grove after July 4th parade.

New Business:

Councilman Kelly said Rotary Club has been made aware of an urgent need for family to host a teenage boy from France. Any interested families should reach out to Councilman Kelly.

Public Comment:

Paul Latsounas, 50 Beverly Road, is opposed to proposed dog park at Hoffman Field.

Mary Margaret Carter, 767 Park Ave., complimented Borough employees during the 4th of July parade and festivities.

Joanne Buonacore, 82 Beverly Rd., offered her opposition to the dog park.

Greg Trass, Maple Ave., asked for clarification regarding the required amount of affordable housing units. Mr. Oddo referred the resident to the settlement agreement.

Lorraine Bogert, Wanamaker Ave., wondered if the unmet need reflected in the current agreement with Fair Share Housing also seeks to address unmet need for future Fair Share Housing contract negotiations. Councilman Carnevale explained that the settlement agreement protects the Borough from developers' lawsuits until 2025 until the agreement is re-evaluated.

Theresa Trass, Maple Ave., stated she understood the Planner planned for an additional story in business district. Mr. Oddo stated he is not involved with the Master Plan proceedings.

He commented that Fair Share Housing agreement includes, the west side of Kinderkamack would be zoned for one story residential and two stories above.

Councilman Tashjian said that Planning Board has made an incredible effort to be transparent in terms of including public in discussions concerning Master Plan.

Greg Trass, Maple Ave., asked who was on the Planning Board Master Plan subcommittee. Councilman Carnevale responded Chairman Gregg Larson, Greg Derian, and Vince Scalcione.

Paul Latsounas, 50 Beverly Road, said that the new ShopRite in New Milford has two retention ponds. The ponds will create a haven for mosquitoes. Mayor Didio responded that the County sprays for mosquitoes.
