Mayor Didio opened the public hearing:

League Presidents from Football, Lacrosse and Soccer (Tom Kiernan, Sabu Idiculla, and Jim Boyle) spoke of the detriment this ordinance would have on players, and their families. They all presented petitions signed by their organizations urging the rejection of the ordinance. They continued with commentary about hosting a meeting with all the leagues and the Borough to try to resolve the financial issues. They also stated that they may be able to bridge some of the communications with the Borough of River Edge.

Bill Boyle, and Roger Tagget, Oradell residents also spoke against passing the ordinance.

Paul Latsounsas and Chip Nobile, Oradell residents spoke in support of passing the ordinance.

The Council discussed the need for passing the ordinance as well as finding solutions and a balance with working with the leagues. Mayor Didio suggested passing this ordinance so that it will supersede the

previous ordinance that has a higher fee and set aside a 60-day moratorium to meet with the leagues. The deadline for the moratorium is February 17, 2020. The Council agreed to these terms.
